#### 3. Plagiarism Policy of ILE

anywhere. It also means translation from one language to another for committing plagiarism. The ILE will use Plagiarism Checker X software for Detecting plagiarism.

#### **4. Zero Tolerance Policy**

The core work carried out by the Participant shall be based on original ideas and shall be covered by Zero Tolerance Policy on Plagiarism. The core work shall include abstract with keywords, introduction, objective, hypothesis, research methodology, analysis and interpretation, summary and observations, conclusions, recommendations and references. If ILE found more than 40% of plagiarism in any document, we will report it to the competent/designated officer of Plagiarism Disciplinary Authority. The authorities of HEI will take suo moto notice of an act of plagiarism and initiate proceedings under these regulations. Similarly proceedings can also be initiated by the HEI on the basis of findings of an examiner.

- In the Internship Period, participants must prepare a Research Article/Article per 2 week (Totally 4 Research Article/Article). You can submit before 2 weeks i.e. One week, but maximum allowed time limit is 2 weeks per article.

- Every two Week participants should submit their Research Article/Article in the provided submission link.

- Participants' qualified Research Article/Article will be published with a publication certificate in the Institute of Legal Education's Scholarly Journals at the free of cost with ISBN. #### **SUBMISSION GUIDELINES**

#### I. General Guidelines

- Research Article/Article must be accompanied by an ABSTRACT not exceeding 300 words.
- ♣ All works must be original and unpublished, and must not be pending for review before any other journal. Any form of plagiarism will result in immediate **DISQUALIFICATION** form the competition.

#### **II. Manuscript Format**

- ♣ The main body of the manuscript should be in **TIMES NEW ROMAN** style, font size 12, with 1.5 line spacing.
- ♣ Footnotes in Times New Roman Style, Size 10, with 1.0 line spacing.
- All headings must have uniform formatting.
- ♣ All entries should be submitted in .doc or .docx and .pdf format.
- **↓** Texts and footnotes should conform to the **BLUEBOOK 20TH EDITION**.
- ♣ If draft failed to adhere Manuscript Format Guidelines, IT WILL BE REJECTED.

#### III. Which Article submission we will not take for the Review Process

- Articles without the Title, Author Name, Author Designation and Abstract.
- ♣ Articles non-compiling 20<sup>th</sup> Bluebook Citation Format
- Articles without Reference Section.

#### IV. Heading Format

- **Lesson** Each heading in the body of the article must be numbered.
- ♣ The main headings should be numbered I, II, III and so on.
- ♣ The second level of headings should be numbered A, B, C, and so on.
- ♣ Both the first and second levels of headings should have the first letter of the main words capitalized.
- ♣ The third level of headings should be numbered 1, 2, 3 and so on.
- ♣ The fourth level of headings should be numbered (i), (ii), (iii) and so on.
- ♣ The third and fourth level of headings should have only the first letter of the heading capitalized.

# For Example:

- I. Laws In India. (First Level Heading)
  - A. The Constitution of India, 1950. (Second Level Heading)
    - 1. Article 13. (Third Level Heading)
      - (i). Doctrine of Eclipse. (Fourth Level Heading)

#### V. Categories of Manuscript

- Research Papers (Min 3000 and No Limit for Maximum)
- Articles (Min 2000 and No Limit for Maximum)

#### A. Research Papers (3000-No limit for Maximum)

Submissions in this category are expected to engage with the theme and literature of a particular topic comprehensively. The manuscript must survey current practice in the field, identify any lacunae and offer innovative reassessment along with constructive suggestions. Theoretical pieces are also welcome in this category.

#### B. Articles (2000-No Limit for Maximum)

Articles are more concise in scope and are focused on a particular issue and offer new perspectives and critical insights on the selected topic. They offer clearly identifiable arguments and may provide different ways of conceptualizing the selected issue.

For **ARTICLE CATEGORIES MANUSCRIPT** must have Followings in their Manuscripts:

- **♣** Title of Paper
- ♣ Author/Co-Author Name, Designation, Email and Phone Numbers (as Foot Note No 1/2).
- ♣ Abstract (Not exceeding 300 Words)
- **♣** Keywords (Minimum 5)
- **♣** Introduction
- **♣** Sub Part/Headings (Minimum 2 and Maximum 5)
- **4** Conclusions
- Reference Section.
